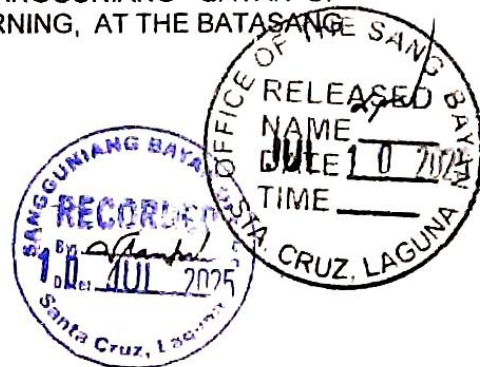

RESOLUTION NO. 115-S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO AN AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE LAND TRANSPORTATION OFFICE REGION IV-A, REPRESENTED BY ITS CHIEF OF OFFICE FOR THE ISSUANCE OF LICENSE PLATES AND MOTOR VEHICLE FRANCHISES

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, the attached Memorandum of Agreement (MOA) between the Land Transportation Office Region IV-A and the Municipality of Santa Cruz, Laguna covers the receiving and delivering of license plates to motor vehicles, both private and for hire, including public motorized tricycles currently operating within its jurisdiction;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Transportation and Communication of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body found it important in bringing its services closer to the citizens;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Ambiel John C. Panganiban (Chairman of Committee on Transportation and Communication, duly seconded by the Hon. Norman T. Tolentino and with the unanimous consent and approval of all the members present, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign and enter into an agreement on behalf of the Municipal Government of Santa Cruz, Laguna, with the Land Transportation Office Region IV-A, represented by its Chief of Office for the issuance of license plates and motor vehicle franchises.

ORDERED : Let copies of this resolution be furnished the Hon. Mayor Edgar S. San Luis, the Municipal Administrator, the Municipal Accountant, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Coordinator, the Municipal Engineering, the Santa Cruz Traffic Management Office, the Santa Cruz Police Station, the Land Transportation Office Region IV-A, the Laguna Traffic Management Office and all others concerned, for their information and appropriate action.
