RESOLUTION NO. 127 S2025

A RESOLUTION AUTHORIZING THE HON. MAYOR JOSEPH KRIS BENJAMIN B. AGARAO FOR THE CLEARANCE AND PREPARATION OF A PORTION OF THE PUBLIC MARKET AREA IN SANTA CRUZ, LAGUNA, FOR THE RETURN OF PREVIOUS STALL HOLDERS.

WHEREAS, a portion of the Public Market area in Santa Cruz, Laguna was razed by fire on May 23, 2025; and

WHEREAS, there is a need to clear the affected area and prepare it for the return of previous stall holders; and

WHEREAS, the undersigned has requested authority to conduct the necessary cleanup and planning for the re-allocation of stalls and to close the affected street during the clearing and cleaning operations;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Market and Slaughterhouse of this sanggunian;

NOW THEREFORE, on motion of the Hon. Mark Anthony M. Juangco (Chairman of Committee on Market and Slaughterhouse), duly seconded by all the members present, it was

RESOLVED: be it resolved, as it is hereby resolved, by the Sangguniang Bayan of Santa Cruz, Laguna, to authorize the Hon. Mayor Joseph Kris Benjamin B. Agarao to proceed with the clearance and preparation of the public market area affected by the fire on May 23, 2025. The area to be cleared is specifically the portion along P. Guevarra St., from the Catholic Church. The objective is to enable the administration to plan the probable return of the previous stall holders/occupants of the said market area.

Agarao, the Municipal Administrator, the Municipal Accountant, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Coordinator, the Municipal Engineer, the Municipal Public Market Officer, SCTMO, the Municipal General Services Officer, Sangguniang Barangay of Poblacion V, and all other concerned offices, for their information and appropriate action.
