RESOLUTION NO. 142-S2025

A RESOLUTION AUTHORIZING THE SANGGUNIANG BARANGAY POBLACION II, SANTA CRUZ, LAGUNA, CHAIRED BY HON. NEMESIS ALDREUS B. LAVINA, TO CONSTRUCT COMFORT ROOMS AT A PORTION OF A LOT IN THE SANTA CRUZ ELEMENTARY SCHOOL WHICH IS A PROPERTY OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA.

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, Dr. Eva Marie S. Cambe, Public Schools District Supervisor, requested the construction of comfort rooms on a portion of a lot within the Santa Cruz Elementary School;

WHEREAS, a request letter from Hon. Nemesis Aldreus B. Lavina, Barangay Chairman of Poblacion II, Santa Cruz, Laguna was submitted through Dr. Loredel C. Gecalao, Principal IV of Santa Cruz Elementary School, Santa Cruz Sub-Office, seeking approval of project proposal, construction of comfort room which will occupy a portion of the school's property;

WHEREAS, the project aims to enhance the quality of life of the residents through the beautification and rehabilitation of public spaces and structures as part of barangay development plan;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Public Works, Infrastructure, and Electrification and Committee on Education of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body found it significantly contribute to the overall welfare of the community by providing essential facilities that promote hygiene and comfort;

NOW THEREFORE, on motion of the Hon. Ambiel John C. Panganiban (Chairman of the Committee on Public Works, Infrastructure and Electification), duly seconded by the Hon. Roselon F. Pamatmat, Hon. Jericho V. Asinas and Hon. Norman T. Tolentino and with the unanimous consent and approval of all the members present, it was

RESOLVED: To authorize the Sangguniang Barangay Poblacion II, Santa Cruz, Laguna, Chaired by Hon. Nemesis Aldreus B. Lavina, to construct comfort rooms at a portion of a lot in the Santa Cruz Elementary School which is a property of the Municipal Government of Santa Cruz, Laguna.
