A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND EXECUTE THE GRANTING OF RIGHT OF WAY TO MANILA ELECTRIC RAILROAD AND LIGHT COMPANY (MERALCO) IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA FOR AND IN CONSIDERATION OF THE INSTALLATION OF ELECTRICAL FACILITIES IN PUROK 1-2, BARANGAY ALIPIT, MAGDALENA, LAGUNA.

WHEREAS, the Manila Electric Railroad and Light Company (MERALCO) has requested a grant of right of way for the extension of its electrical facilities in Purok 1-2, Barangay Alipit, Magdalena, Laguna;

WHEREAS, the Sangguniang Bayan finds the request meritorious and necessary for the improvement of electrical services in the said barangay;

WHEREAS, a map of the affected area and a detailed project description have been submitted and reviewed by the Sangguniang Bayan;
