A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO AN AGREEMENT IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE PHILIPPINE RED CROSS WITH RESPECT TO BLOOD REQUEST ASSISTANCE DONATIONS THAT WILL BENEFIT TO OUR CONSTITUENTS.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Joseph Kris Benjamin B. Agarao to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, after a careful study and evaluation of the said agreement, by the concerned body, it was deemed proper to grant an authority to the Municipal Mayor Joseph Kris Benjamin B. Agarao to sign and enter into an agreement with the Philippine Red Cross with respect to blood donations that will benefit to our constituents.

NOW THEREFORE, on motion of the Hon. Jericho V. Asinas (Chairman of Committee on Health, Nutrition and Sanitation), duly seconded by all the members of the Sangguniang Bayan present, it was
