A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH KRIS BENJAMIN B. AGARAO, TO ENTER INTO A CONTRACT OF SERVICE WITH DR. ANTHONY C. LEACHON FOR COMPREHENSIVE HEALTH EDUCATION, HEALTH DISEASE PREVENTION, NON-COMMUNICABLE DISEASES AND UNIVERSAL HEALTH CARE AMONG OTHERS IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, the Municipality of Santa Cruz, Laguna, recognizes the crucial need for comprehensive health services to improve the well-being of its constituents;

WHEREAS, Dr. Anthony C. Leachon possesses extensive expertise and experience in public health, making him a highly qualified candidate to provide these essentials services;

WHEREAS, a thorough evaluation of Dr. Leachon's qualifications and proposed services has been conducted, demonstrating his suitability for the role;
