A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO EXECUTE A DEED OF DONATION FOR A PARCEL OF LAND OWNED BY THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, IN FAVOR OF THE PROVINCIAL OFFICE OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG).

WHEREAS, the Municipal Government of Santa Cruz, Laguna owns a parcel of land situated at 1588-A, Block 2, Dampa Galing sa Puso, Brgy. Bagumbayan, Santa Cruz, Laguna;

WHEREAS, this land donation is intended for use by the Provincial Office of the Department of the Interior and Local Government (DILG) to construct a training center, conduct seminars, and provide additional parking;

WHEREAS, after careful study and evaluation of the proposed Deed of Donation by the concerned body, it is deemed appropriate to authorize Municipal Mayor Joseph Kris Benjamin B. Agarao to execute the Deed of Donation with the Provincial Office of the DILG to ensure more effective and efficient training programs benefiting DILG employees and the public;
