AGARAO TO ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH THE SOUTH LUZON PRIME MEDICAL INC., WITH OFFICE ADDRESS AT PRIMARK TOWN CENTER, SITIO MAPAGMAHAL, BRGY. PAGSAWITAN, SANTA CRUZ, LAGUNA, WITH RESPECT TO THE MANDATORY DRUG TESTING FOR ALL EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Joseph Kris Benjamin B. Agarao to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the attached Memorandum of Agreement (MOA) between the South Luzon Prime Medical Inc., and the Municipal Government of Santa Cruz, Laguna for the conduct of mandatory drug testing for all municipal employees to be scheduled;
