RESOLUTION NO. 330- S2025

A RESOLUTION RENAMING THE ANNEX BUILDING OF THE MUNICIPAL HALL AS “MULTI-PURPOSE BUILDING” TO ENABLE THE MUNICIPAL GOVERNMENT TO UTILIZE THE SAID BUILDING FOR OTHER PURPOSES NOT MERELY FOR ADMINISTRATIVE FUNCTIONS.

Sponsor – HON. ESMERALDO C. DE LAS ARMAS, JR.

WHEREAS, the Office of the Municipal Mayor, through a 1st Indorsement dated July 14, 2025, respectfully requested the Sangguniang Bayan to pass a resolution renaming the Annex Building of the Municipal Hall;

WHEREAS, based on DBM-DOF Joint Memorandum Circular No. 1, issued on November 4, 200, the 20% Development Fund must be used for development projects that directly support social, economic and environmental outcomes. So, if a building is intended and being used for public use such as: health services, community development and meetings, livelihood training centers, social services rendered by the Municipal Social Welfare and Development Office, the building can be considered as a Multi-Purpose Building, entitled to be funded under the 20% Development Fund;

WHEREAS, the purpose of said renaming is to formally designate the facility as a “Multi-Purpose Building,” allowing the Municipal Government to maximize its use for various activities and services beyond administrative functions;

WHEREAS, it is imperative to align the name of the building with its intended flexible function for better identification and use in public documents and communications;

NOW, THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by all the members of the Sangguniang Bayan, it was

RESOLVED, as it is hereby Resolved, to approve the renaming of the Annex Building of the Municipal Hall as “Multi-Purpose Building” to enable the Municipal Government to utilize the said building for other purposes not merely for administrative functions.
