RESOLUTION NO. 360- S2025

RESOLUTION ENDORSING AND ENCOURAGING SUPPORT OF THE OFFICE OF THE PROVINCIAL GOVERNOR MARISOL ARAGONES OF LAGUNA FOR THE CONSTRUCTION OF A TWO (2) FOUR-STOREY BUILDING WITH 32 CLASSROOMS AT GOV. FELICISIMO T. SAN LUIS INTEGRATED SENIOR HIGH SCHOOL (GFTSISHS).

WHEREAS, Gov. Felicisimo T. San Luis Integrated Senior High School (GFTSISHS) is committed to providing quality, inclusive education to the students of Brgy. Bubukal, Santa Cruz, Laguna;

WHEREAS, Gov. Felicisimo T. San Luis Integrated Senior High School (GFTSISHS) has experienced a consistent increase in student enrollment, demonstrating the community's trust in the institution;

WHEREAS, Gov. Felicisimo T. San Luis Integrated Senior High School (GFTSISHS) is the only school in the province of Laguna offering the Special Program in Sports (SPS), requiring facilities that support both academic instruction and athletic development;

WHEREAS, Gov. Felicisimo T. San Luis Integrated Senior High School (GFTSISHS) has been a regular host and billeting site for various DepEd and LGU-led activities, which, while beneficial, place a strain on existing classroom spaces;

WHEREAS, the school faces persistent infrastructure challenges, including a shortage of classrooms and the continued use of makeshift and inadequate learning spaces, hindering the learning experience and academic growth of students;

WHEREAS, a proposed budget allocation for new school buildings was identified in 2019 but was not realized due to the COVID-19 pandemic;

WHEREAS, the need for improved infrastructure has become even more urgent due to the growing student population; and

WHEREAS, the construction of a two (2) four-storey building with 32 instructional classrooms, comfort rooms, and an athlete dormitory would address these critical needs;

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman of Committee on Education), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Jericho V. Asinas and Hon. Mark Anthony M. Juangco and with the approval of the members of the Sangguniang Bayan, it was

RESOLVED: that the Sangguniang Bayan of Santa Cruz, Laguna, hereby endorses and encourages the support of the Office of the Provincial Governor Marisol Aragones of Laguna for the proposed construction of a two (2) four-storey building with 32 classrooms at Gov. Felicisimo T. San Luis Integrated Senior High School ((GFTSISHS).
