## RESOLUTION NO. 108-S2025

A RESOLUTION ACCOMMODATING VENDOR STALLS/TRADERS SPECIFICALLY WHO WERE AFFECTED BY FIRE INCIDENT IN THE PUBLIC MARKET FROM JUNE 2 TO JUNE 29, 2025, ALONG THE PORTIONS OF CAILLES STREET FROM THE SANTA CRUZ BRIDGE TO THE FRONT OF THE MUNICIPAL HALL; J.P. RIZAL STREET (FRONT OF ESCOLAPIA BUILDING) INCLUDING PORTIONS OF P.GUEVARRA STREET, VALENZUELA STREET, AND ZULUETA STREET, IN CELEBRATION OF THE FEAST DAY OF OUR LADY OF MAULAWIN.

WHEREAS, the Feast Day of Our Lady of Maulawin is an important local celebration that gathers people and fosters community spirit in the Municipality of Santa Cruz, Laguna,

WHEREAS, the local government recognizes the importance of supporting local economic activities by providing opportunities for vendors and traders during the festive season;

WHEREAS, the Hon. Mayor Edgar S. San Luis has endorsed an urgent resolution to allow the establishment of vendor stalls/traders from June 2 to June 29, 2025, in the following areas: portions of Cailles Street from the Santa Cruz Bridge to the front of the Municipal Hall, J.P. Rizal Street (front of Escolapia Building) Portions of P. Guevarra Street, Valenzuela Street, and Zulueta Street;

WHEREAS, vendor stalls/traders on Cailles Street will be established daily starting from June 2, 2025 until June 29, 2025, and will be open from 6:00PM to 12:00 AM, while those in all other streets may established daily for the same duration during the stated period;

WHEREAS, the aforementioned arrangements will accommodate the night market and are expected to attract more investments and boost the local economy during the celebration period;

WHEREAS, the vendors whose stalls were affected by fire incident in the public market are exempted from paying special business permit fees, including barangay clearance;

WHEREAS, that portions of the said streets, when necessary, shall be closed to vehicular traffic to accommodate the night market and ensure the safety of the public.

NOW, THEREFORE, on motion of Hon. Mark Anthony M. Juangco, duly seconded by Hon. Lea A. Almarvez, Hon. Norman T. Tolentino, Hon. Rizaldy N. Kalaw, Hon. Laura P. Obligacion and Hon-Esmeraldo C. Delas Armas, Jr. be it:

RESOLVED, as it is hereby RESOLVED, to accommodate vendor stalls/traders specifically who were affected by fire incident in the public market from June 2 to June 29, 2025, along the portions of Cailles Street from the Santa Cruz Bridge to the front of the Municipal Hall; J.P. Rizal Street (Front of Escolapia Building) including portions of P.Guevarra Street, Valenzuela Street, and Zulueta Street, in Celebration of the Feast Day of Our Lady of Maulawin.
