A RESOLUTION RESPECTFULLY REQUESTING HONORABLE SENATOR JOSEPH VICTOR "JV" G. EJERCITO, OF THE REPUBLIC OF THE PHILIPPINES TO PROVIDE ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS) TO THE CONSTITUENTS OF THE MUNICIPALITY OF SANTA CRUZ, PROVINCE OF LAGUNA.

WHEREAS, the Department of Social Welfare and Development (DSWD) implements the Assistance to Individuals in Crisis Situation (AICS) Program, which provides medical, burial, transportation, food, educational, and other forms of financial support to individuals and families in crisis;
