A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE SENATOR LOREN LEGARDA OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS FOR THE IMPLEMENTATION OF THE TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED /DISPLACED WORKERS (TUPAD) PROGRAM IN THE MUNICIPALITY OF SANTA CRUZ, PROVINCE OF LAGUNA.

WHEREAS, the Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD) is a community-based package of assistance implemented by the Department of Labor and Employment (DOLE), which provides emergency employment to displaced, underemployed, and seasonal workers;

WHEREAS, the TUPAD program plays a vital role in mitigating the impact of poverty and unemployment, especially among the vulnerable and marginalized sectors of society by providing shortterm, wage-based employment and skills development;

WHEREAS, the Municipality of Santa Cruz, Province of Laguna, has a significant number of residents who are considered disadvantaged or displaced due to various socio-economic factors and would greatly benefit from the said program;

WHEREAS, the Local Government of Santa Cruz, led by Honorable Mayor Joseph Kris Benjamin B. Agarao supported by the Sangguniang Bayan, is steadfast in its efforts to promote inclusive and sustainable local employment opportunities for its constituents;

WHEREAS, the support of the Honorable Senator Loren Legarda in the form of fund allocation for the TUPAD program in the Municipality of Santa Cruz would enhance the delivery of meaningful employment assistance to the local community;
