A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE SENATOR ERWIN T. TULFO OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS FOR THE IMPLEMENTATION OF THE TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED /DISPLACED WORKERS (TUPAD) PROGRAM IN THE MUNICIPALITY OF SANTA CRUZ, PROVINCE OF LAGUNA.

WHEREAS, the Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (TUPAD) is a community-based package of assistance implemented by the Department of Labor and Employment (DOLE), which provides emergency employment to displaced, underemployed, and seasonal workers;

WHEREAS, the TUPAD program plays a vital role in mitigating the impact of poverty and unemployment, especially among the vulnerable and marginalized sectors of society by providing shortterm, wage-based employment and skills development;

WHEREAS, the Municipality of Santa Cruz, Province of Laguna, has a significant number of residents who are considered disadvantaged or displaced due to various socio-economic factors and would greatly benefit from the said program;
