A RESOLUTION RESPECTFULLY REQUESTING HONORABLE SENATOR JOEL VILLANUEVA OF THE REPUBLIC OF THE PHILIPPINES TO PROVIDE MEDICAL ASSISTANCE UNDER THE MEDICAL ASSISTANCE FOR INDIGENT PATIENTS (MAIP) PROGRAM FOR QUALIFIED RESIDENTS OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, the Municipal Government of Santa Cruz, Laguna, under the leadership of Honorable Mayor Joseph Kris Benjamin B. Agarao, remains committed to promoting and protecting the general welfare of its constituents, particularly the marginalized and underprivileged sectors;
