A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE LAGUNA STATE POLYTECHNIC UNIVERSITY REPRESENTED BY ITS UNIVERSITY PRESIDENT, MARIO R. BRIONES, EdD., FOR IMPLEMENTATION OF ON-THE-JOB (OJT) TRAINING PROGRAM OF THE COLLEGE OF INDUSTRIAL TECHNOLOGY OF LSPU-SCC.

WHEREAS, a copy of Memorandum of Agreement (MOA) was indorsed by the Honorable Municipal Mayor Joseph Kris Benjamin B. Agarao to this august body for the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the LSPU has instituted the On-the-Job Training (OJT) Program as part of the curriculum requirements of the academic programs under the College of Industrial Technology ("the College" for brevity) in order to provide its qualified students with adequate experience in actual industry work operations and to augment their formal education;

WHEREAS, the mentioned On-the-Job Training (OJT) Program which contains the outlined goals and objectives, knowledge, skills, and competencies that the student-trainees should acquire in each training area, assignment, and schedule of activities, among others shall be further specified in the relative approved OJT Plan pursuant with all the necessary academic policies which includes the CHED Memorandum Order No. 104, Series of 2017;

WHEREAS, the PARTNER ESTABLISHMENT, supports the mentioned On-The-Job Training (OJT) Program and is willing to be an Host Training Establishment (HTE) who shall accept and accommodate said qualified student trainees of the College in providing actual industry work operations;

WHEREAS, after a careful study and deliberation of the said committee, this body found it important in bringing its extension of services in livelihoods trainings;

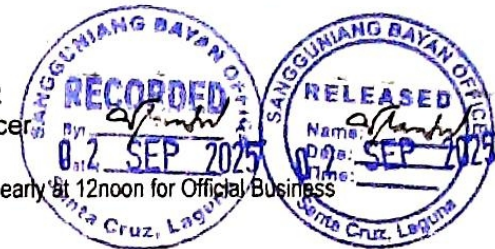
WHEREAS, the said agreement is binding and should be implemented accordingly.
