A RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF LAGUNA PRIVATE SCHOOL'S ADMINISTRATORS ASSOCIATION (LAPPRISADA) STA. CRUZ SUB CHAPTER IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 23, 2025 the Department of Interior and Local issued Memorandum Circular No. 2025-060 on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the LAGUNA PRIVATE SCHOOL'S ADMINISTRATORS ASSOCIATION (LAPPRISADA) STA. CRUZ SUB CHAPTER through its President – Jocelyn Q. Valdeabella has signified its intention to be an accredited Civil Society Organization (CSO) in the Municipality of Santa Cruz, Laguna to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;
