RESOLUTION NO. 256- S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), RENEWING THE PREVIOUS AGREEMENT ALLOWING EMPLOYEES OF THE MUNICIPAL GOVERNMENT TO SECURE SALARY LOAN FROM DBP.

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, the attached Memorandum of Agreement with the Development Bank of the Philippines (DBP), renewing the previous agreement allowing employees of the Municipal Government to secure salary loan from DBP;

WHEREAS, it appears that as of June 30, 2025, the existing credit limit of the Municipality for the Salary Loan is Sixty Million Pesos, with an outstanding balance of Nineteen Million One Hundred Three Thousand Six Hundred Sixty Nine Pesos and Eighty Eight Centavos (P19,103,669.88);

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Finance, Budget and Appropriation of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body found it important in bringing its renewing of services in addressing the needs of employees for the salary loan;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Rizaldy N. Kalaw (Chairman of Committee on Finance, Budget and Appropriation), duly seconded by the Hon. Roselon F. Pamatmat, Hon. Ambiel John C. Panganiban and Hon. Lea A. Almarvez and with the approval of the members of the Sangguniang Bayan present, it was
