A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE UNIVERSITY OF THE PHILIPPINES LOS BAÑOS, LAGUNA, A NATIONAL UNIVERSITY OF THE PHILIPPINES, REPRESENTED BY CHANCELLOR, DR. JOSE V. CAMACHO, JR.

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, the attached Memorandum of Agreement (MOA) between the University of the Philippines Los Baños and the Municipal Government of Santa Cruz, Laguna for the implementation of project titled "Improving Agricultural Productivity and Competitiveness of Women Livelihood Operators through Gender-Responsive S&T Strategies" funded by the Philippine Council for Agriculture, Aquatic, and Natural Resources Research Development (PCAARRD) led by Asst. Prof Lei A. Pangilinan - Jamolin;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Livelihood, Trade and Industry of this sanggunian;
