**RESOLUTION REQUESTING TO HONORABLE MARISOL “SOL” CASTILLO ARAGONES-SAMPELO, GOVERNOR OF LAGUNA, FOR THE INCLUSION OF THE FOLLOWING PROJECTS TO BE FUNDED UNDER THE 20% DEVELOPMENT FUND OF THE PROVINCE OF LAGUNA, FOR THE YEAR 2026, TO WIT: TO APPROVE THE INCLUSION OF VARIOUS DEVELOPMENT PROJECTS UNDER THE 20% DEVELOPMENT FUND OF THE PROVINCE OF LAGUNA FOR THE YEAR 2026.**

**WHEREAS**, the Local Government Code of 1991 mandates that local government units allocate twenty percent (20%) of their annual internal revenue allotment for development projects;

- Barangay Santisima Cruz, Santa Cruz, Laguna (P5,000,000.00)
- Barangay Bagumbayan, Santa Cruz, Laguna (P5,000,000.00)

**Construction of Barangay Road:**

- Barangay Labuin, Santa Cruz, Laguna (P5,000,000.00)
- Barangay San Pablo Norte, Santa Cruz, Laguna (P5,000,000.00)
