A RESOLUTION AUTHORIZING THE HON. MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO ENTER INTO A CONTRACT OF SERVICE, WITH MR. RAUL SIOSON BALDOVINO, FOR THE LATTER TO RENDER SERVICE TO THE MUNICIPALITY TO ASSIST IN THE IMPLEMENTATION OF AGRICULTURAL PROGRAMS, PROJECTS, AND ACTIVITIES OF THE OFFICE OF THE MUNICIPAL AGRICULTURIST.

WHEREAS, the Hon. Mayor Joseph Kris Benjamin B. Agarao indorsed to the Sangguniang Bayan for a resolution granting him an authority to enter into a Contract of Service with Mr. Raul Sioson Baldovino;
