A RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF PEDERASYON NG KABABAIHAN LINGKOD BAYAN SA PILIPINAS INCORPORATED (PKLBPI) IN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 23, 2025 the Department of Interior and Local issued Memorandum Circular No. 2025-060 on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the PEDERASYON NG KABABAIHAN LINGKOD BAYAN SA PILIPINAS INCORPORATED (PKLBPI) through its President - Salve Lopez has signified its intention to be an accredited Civil Society Organization (CSO) in the Municipality of Santa Cruz, Laguna to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the PEDERASYON NG KABABAIHAN LINGKOD BAYAN SA PILIPINAS INCORPORATED (PKLBPI) has satisfactory complied with the requirements and criteria for accreditation as a Civil Society Organizations in accordance with the procedures and guidelines set forth in DILG MC 2025 -060;

WHEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of Committee on Laws and Ordinances), duly seconded by all members present, be it,

RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to approve and grant the accreditation of PEDERASYON NG KABABAIHAN LINGKOD BAYAN SA PILIPINAS INCORPORATED (PKLBPI) in the Municipality of Santa Cruz, Laguna.
