LYNETTE V. ORTIZ, THROUGH HER DULY AUTHORIZED REPRESENTATIVE, BABY MAUREEN P. CASTALONE, BRANCH HEAD, SANTA CRUZ, LAGUNA FOR AVAILING THE LANDBANK'S DEPOSIT PICK-UP SERVICES.
