RESOLUTION NO. 258- S2025

A RESOLUTION AUTHORIZING THE HON. MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE SANTA CRUZ DENTAL CLUB, ALLOWING THE LATTER TO USE A BUILDING OWNED BY THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA.

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, a five (5)-year use agreement is hereby granted to the Santa Cruz Dental Club for the use of the Municipal Building located in Brgy. Bubukal, Santa Cruz, Laguna. this agreement may be renewed at the discretion of the Municipal Government;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Laws and Ordinances, Committee on Health, Nutrition, and Sanitation and Committee on Housing and Land Use of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body deems it beneficial to grant the Santa Cruz Dental Club's request, considering the potential benefits to the community;

WHEREAS, the said agreement is binding and should be implemented accordingly.
