A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA REFERRED AS THE RURAL HEALTH UNIT, WITH THE LAGUNA STATE POLYTECHNIC UNIVERSITY (LSPU) REPRESENTED BY ITS UNIVERSITY PRESIDENT, MARIO R. BRIONES, EdD FOR THE IMPLEMENTATION OF THE STUDENT TRAINING AND AFFILIATION OF THE COLLEGE OF NURSING AND ALLIED HEALTH (CONAH) – LSPU SANTA CRUZ CAMPUS.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Joseph Kris Benjamin B. Agarao to this august body with the purpose as stipulated in the above-mentioned title of this resolution;
