RESOLUTION NO. 338-S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE GREENERY WASTE MANAGEMENT SERVICES REGARDING THE FACILITATION AND MANAGEMENT OF TREATMENT AND HAULING PATHOLOGICAL INFECTIOUS WASTE.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Joseph Kris Benjamin B. Agarao to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, after a careful study and evaluation of Committee on Natural Resources and Environment and Committee on Finance, Budget and Appropriation the said agreement, by the concerned body, it was deemed proper to grant an authority to the Municipal Mayor Joseph Kris Benjamin B. Agarao to sign and enter into an agreement with the Greenery Waste Management Services, advantageous to the welfare and benefits of the constituents;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Mark Anthony M. Juangco (Chairman - Committee on Natural Resources and Environment), duly seconded by the Hon. Roselon F. Pamatmat and with the approval of the members of the Sangguniang Bayan present, it was
