RESOLUTION NO. 340- S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSEPH KRIS BENJAMIN B. AGARAO TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE EVERGREEN LABS PHILIPPINES CONSULTING INC., A COMPANY INCORPORATED IN PHILIPPINES WHOSE REGISTERED ADDRESS IS SITUATED AT 6TH FLOOR, ONE AYALA AVENUE, TOWER 2 AYALA AVENUE, AYALA CENTER, SAN LORENZO, CITY OF MAKATI, FOURTH DISTRICT, NATIONAL CAPITAL REGION (NCR), PHILIPPINES, 1223 FOR THE FACILITATION AND MANAGEMENT OF COLLECTION, SEGREGATION, RECYCLING, AND DISPOSAL OF VARIOUS TYPES OF WASTE WITHIN THE MUNICIPALITY.

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Joseph Kris Benjamin B. Agarao to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, Memorandum concerns the facilitation and management of collection, segregation, recycling, and disposal of various types of waste within the Municipality;

WHEREAS, This Agreement shall begin on the Effective Date and shall continue for twelve (12) months. The Agreement will automatically renew each year until terminated by either Party. Sixty (60) days prior to each annual renewal the Parties will negotiate in good faith to update the Program to reflect changes in costs, pricing, activities or locations;

WHEREAS, after a careful study and evaluation of Committee on Natural Resources and Environment and Committee on Finance, Budget and Appropriation the said agreement, by the concerned body, it was deemed proper to grant an authority to the Municipal Mayor Joseph Kris Benjamin B. Agarao to sign and enter into an agreement with the Greenery Waste Management Services, advantageous to the welfare and benefits of the constituents;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Mark Anthony M. Juangco (Chairman of Committee on Natural Resources and Environment), duly seconded by the Hon. Jericho V. Asinas and Hon. Norman T. Tolentino and with the approval of the members of the Sangguniang Bayan present, it was
